The Department of Corrections (DOC) and CCI have created a partnership wherein selected inmates may learn to train a CCI puppy.

- O Can I find a compatible cellmate that would want to live with me, a puppy, and the supplies in a small area?
- O Am I a team player?

- O Am I ready and willing to commit to at least 24 months of my time, dedicating it to training a puppy?
- O Can I work as a team member even if I don't like another member?
- O Am I open minded to learning new ways of communicating, interacting with others, accepting of criticism, and flexible enough to go with the flow of change?

# Eligibility for Hire:

- o Have a high school diploma, a GED, or be working toward it, (preference may be given to those that already have their high school diploma or GED).
- o Incentive level 3.
- o One year DR free.
- O Have a release date of 2026 or later.

In addition to the qualifications listed above the screening process will include communication with your supervisor (past/present), security staff, Health Services, BHS, and a review of your criminal record.

as a zero gravity chair. I have never used it for that function because of how it lays a person back but I do raise my legs in it to help with edema. I went to get into the chair and the controls slipped from my hand. When that happened they fell to the floor and became wedged with the buttons pressed making the chair go into full out zero gravity position. I struggled and struggled to get up but I just wasn't strong enough. Omaha was sound asleep in his kennel and came flying out to see what was going on. I couldn't even speak as no air was going in my lungs. I was frantically pointing at the floor and he started looking for what I needed. He was able to dig out the control and picked it up. But he wanted to give it to me from the opposite side of the chair...the cord was too short! I could only flap my hands by now and was going down for the count...he figured I needed him where my hand was flapping and he rushed over to the right side dropping the control in my lap but I couldn't pick it up as I was blacking out by now. He kept pushing it and pushing my hand to where I could feel the buttons and I was able to hit the right one. Up we went! And blessed air started filling my lungs! He fretted over me for about 1/2 hour and is still glued to my side or feet but it is good to have him so close. He is my hero!

#### PRAS REVISIONS

From Ms. Raths, Administrator, Policy and Business Services



As many of you may remember, the Department has been analyzing the current PRAS system in response to a petition to amend the rule. Thank you for your patience as we looked into this very complex system. We are pleased to announce the first PRAS revision; the elimination of the 120-day evaluation period. By eliminating this waiting period, people arriving into our custody will be eligible to earn daily PRAS points on their first day of a qualifying program assignment and no longer need to wait 120 days to do so. This change will go into effect April 1, 2019, and from that time forward the 120-day evaluation period will not be applied. Please note there will be no backdating of points for those impacted prior to April 1, 2019.

Additional positive changes are in store for PRAS, and efforts to automate those changes are underway. We are eager to provide you system improvements and will communicate those changes as they become ready.

### Flu Vaccines Offered

From Health Services



It is nearly spring again and the flu season has been harsh. Health Services want to remind you to get vaccinated against the flu. Every year ODOC Health Services offer flu vaccines to our adult in custody

(AIC) population. Health Services will be giving Flu Vaccine to Adults in Custody who are at higher risks of the flu first; then it may be offered to the rest of the general population by AIC request. If you would like to get a flu vaccine please send a non-emergent health care request to Health Services so that you can be added to our Flu Vaccine Clinic List. We compile this list starting in September and add to it as the season progresses. When the vaccine becomes available Health Services will start the clinics.

Vaccines help your body build protection against illness. Your body will build antibodies (an-ti-bod-ies) that act as soldiers to protect you against different flu viruses. Each year that you get the vaccine you build up another layer of protection against the ever-changing strains of the flu virus.

year that you get the vaccine you build up another layer of protection against the ever-changing strains of the flu virus. When you get a flu vaccine you may or may not feel like you have a mild flu after you receive a vaccine but this is just your body building the antibodies/soldiers to fight off the flu and feeling mild flu symptoms does not always happen. It is important to know that you cannot actually get sick from receiving a flu vaccine.

Whether or not you choose to get a Flu Vaccine you should remember to do the following throughout the flu season:

Wash your hands frequently. This will help prevent you from getting common colds and help put a stop to your friends and neighbors getting it as well. Please practice this important and simple tool.

Cover your mouth and nose with a tissue or your sleeve (not your hand!) when you cough, sneeze or yawn to prevent germs from spreading. It is better to cough into your elbow. Drink lots of fluids, water, juices, and clear soups will help loosen mucus and keep you from becoming dehydrated. Drink at least 8, 8-ounce cups of water daily. Rest.

If you do get the Flu: Let Health Services know so that they can try and help lesson some of the symptoms and help prevent the spread of the flu to your fellow inmates.

- Send a Non-emergent communication form to Health Services listing your symptoms and how long you have had them.
- You will be scheduled for nurse triage to assess you and determine if treatment or precautions are needed.
- Treatment only lessens the symptoms and duration but does not cure the flu.
- Precautions involves having to wear a mask to prevent you spreading the virus to others and being placed on lay ins so that you rest and do not spread the virus.
- Flu viruses are generally contagious to others for the first 3-4 days after a person is infected.
- The Flu has to run its course.

Health Services cares about you staying healthy and recommends getting the flu vaccine annually.

The process for a visitor application can take up to 6 to 8 weeks. Once the visitor is approved or denied, you will receive notification of the application status. Submitting more than one application per visitor is not productive and will not speed up the process

# Getting Your Minor Child on Your Visiting List

It has recently come to my attention that there is some confusion regarding the parental delegation forms you receive from the law library.



First, this form does not assign guardianship. Only the court can

do that. The form is meant to allow a caregiver permission to act on your behalf in matters such as getting medical care for your child, or signing your child up for school.

In order to get your minor child on your visiting list, you must submit a visiting application, which will then trigger Inmate Services to send a custodial consent letter to the person with legal custody, which must be signed and notarized by that person. (4/30/2019)

# Requirements:

- Child age from birth to Age 5
- Minimum or minimum eligible with gate clearance
- Child lives less than 60 minutes away
- Transportation to/from the school are Tuesday and Thursday 9:00am - 12:30pm

# PREA INFORMATION

From DOC

It is normal for people who experience sexual abuse to feel overwhelmed and have a lot of questions about what their options are. It is also important to remember no one deserves to be sexually abused. It is not your fault. Surviving and healing is possible.

Inmates who have experienced sexual abuse may reach a community-based advocate by dialing "711" from the inmate telephone system. Community-based advocates provide survivors of sexual abuse information about their options, resources, information and emotional support. Calls to "711" are confidential and free of charge.

#### Advocates role

- Provide over-the-phone confidential support and crisis intervention related to sexual abuse
- Talk with a survivor about their current and ongoing safety
- Explain reporting options available through PREA
- Support survivor at a sexual assault forensic medical examination
- Support survivor at an investigatory interview related to sexual abuse, as requested
- Educate/teach survivor coping skills for healing from sexual abuse
- Provide resources and referrals
- Provide follow-up support

# An advocate's role is

- Not make decisions or tell a survivor what to do
- Not tell a survivor whether or not to report
- Not investigate a crime
- Not provide legal advice
- Not be a survivor's friend
- Not provide therapy
- Not communicate with the institution unless the survivor requests them to do so and only with a signed limited release of information

Community-based advocacy centers provide sexual abuse support to people of all genders. Community-based advocates will not report the sexual abuse unless you request them to do so and if you sign a release of information.

Advocacy crisis lines are not a reporting hotline. If you wish to file a report, you may contact the Inspector General Hotline by dialing 9 on the inmate telephone system, writing an inmate communication, filing a grievance, or writing the Governor's Office at State Capitol, Room 160, 900 Court Street, Salem, OR 97301.

# Out of the Classroom and Into the Kives

Two weeks ago a few of the bee team 6 ladies were called out to meet at inmate processing where Cpl. Johnson would take us out to the beehives to access the damage that had taken place to the hives from a long winter. We had a lot of wind, which caused the plastic to be blown off the top of the hives, creating havoc on the hives. This was our first adventure to the hives assisting in some much needed clean-up. Unfortunately we lost quite a few of our honeybees which was a sad loss to see. A feeling of pride was shared amongst us all to be able to physically contribute to the wellbeing of these amazing and magnificent bees. We got things all cleaned up and resituated just in time to go out to the hives the following week.

Wed. March 20, 2019 I was at my bunk when around 1:50 PM I, along with 5 others were called to the Inmate Processing to suit up and get ready to go out to the hives. At first I felt excitement and then I was hit with a large dose of reality of where I was going. I began to question myself "What did you get yourself into?" Because bee's can sense nervous energy I knew how important it would be for me to remain calm and remember to breath.

First we all met in the chow hall where Cpt. McCorkhill and Cpl. Johnson taught us how to recreate the sugar from the

sugar boards into a sugar syrup, adding Honey B Healthy to the sugar syrup which aids in preventing mold in the sugar syrup along with stimulating the bee's immune system, not to mention the spearmint and lemongrass oils used in it smelled incredible! Once we had our sugar syrup made3, off we went. It was warm outside and I wasn't prepared for the heat that I could feel from wearing the bee suit ,gloves, and veil, which are needed to protect oneself from potential bee stings.

With most of us eagerly waiting to take off the tops of the hives, I reminded myself to stay calm and enjoy the process. As we begin to slowly pull frames out, witnessing the busyness of these complex creatures, it was an awe inspiring moment to see just how significant these honeybees are to our world as a whole. It is still astonishing to me home something so small can be so vitally important to our universe. I'm happy to report that three of our queens are alive and appeared to be doing well. We didn't bother them much just eyeing their living situation.

In the week prior we also cleaned up all the proplis (bee glue) and wax, scraping it all from the frames and boxes along with any mold that was present. We were also treated to some fresh honey, which we ate right off of the frames; it was thick, sticky, sweet and rich in color.

No one got stung while we visited the beehives and the experience was 100% positive. I am thankful that I chose to step out of my comfort zone, becoming more educated in the importance of the honeybees and how they affect our livelihood.

# **INCENTIVE MOVES**

From: Captain Wilson

The criteria to request an incentive convenience move is as follows:

- Must be an Incentive Level III.
- If you receive three or more conduct orders (cellins) within a 60-day period starting from the last conduct order or you will lose your incentive move.
- No disciplinary reports within a six-month period.
- You will lose your convenience move status if you receive a disciplinary report.
- Must be in program compliance and have no program failures within the last six months.

- Incentive moves will not be approved for a specific cell, bunk, or tier; incentive moves will be based on housing restrictions and the needs of the facility.
- Incentive moves only last for a six-month period once approved.
- You may only request an incentive move or renewal every six months.
- Incentive level changes due to poor conduct will affect your incentive housing.
- Incentive Move Request Forms must be submitted to the Operations Captain for all incentive moves. The request form must be reviewed and signed by the Unit Officer prior to being submitted to the Operations Captain. (Requests not signed by the Unit Officer will be returned.)

# Incentive Level III inmates requesting housing on J or K Units.

- Incentive Move Request Forms must be submitted to the Operations Captain for all incentive moves. The request form must be review/signed by the Unit Officer prior to being submitted to the Operations Captain. (Requests not signed by the Unit Officer will be returned.)
- Cellmate requests will only be authorized in Incentive Level III Housing Units J and Section A & B of K Unit. Both parties must request the move using the Incentive Move Request form.
- Inmates who have been involved in a sexual misconduct will not be considered for housing requests within the same cell.
- Inmates who have registered, or are registered, as domestic partners will not be housed in the same cell or housed next to each other in a dorm setting.
- Cases involving those inmates who have lost their cellmate due to minimum placement, parole, DSU/Special Housing placement, or any unforeseen circumstance may submit another incentive move request. That request will count as an incentive move for both inmates.
- All housing unit movement into and from MHU / D unit will be coordinated through Behavioral Health Services, the Unit Officer and the Operations Captain

Approved moves will be made as soon as possible, depending on bunk availability, and staff work load.

Inmates will receive a copy of the approved Incentive Move Request noting approval or denial.

The Operations Captain reserves the right to approve or deny any incentive move request based on the needs of the facility.

The Operations Captain retains the authority to remove an inmate from incentive housing based on safety and security concerns.

The Operations Captain retains the authority to make any emergency housing moves, or moves based upon the needs of the facility deemed appropriate, regardless of previous approval.

All facility wide bunk moves are based upon the needs of the facility and the cellmate program.

# Incentive Move Requests:

- Do not attach kytes to your Incentive Move Request. It will be returned.
- A small lined space in the middle of the Incentive Move Request Form is for writing notes to the Operations Captain. Notes anywhere but specified space will result in return of request form.
- Only identify requested Unit, Section (K Unit), or Bottom Bunk (Cadillac Bunk). K Unit is where Cadillac Beds are located and requesting bottom bunks may significantly delay your move.
- Do not send multiple Incentive Move Requests or kytes; they, and the original Incentive Move Request, will be returned.
- If you choose to cancel an incentive move request, the first cancellation will restrict you from requesting another move for 3 months (90 days). The second cancellation will restrict you from requesting a move for 6 months (180 days).

# Kytes to the Operations Captain:

- If you are in Special Housing (DSU/SHU) and are returning to the general population, do not kyte Operations Captain requesting housing consideration. You will be housed accordingly, based on the needs of the facility, Cellmate Program, and any documented conflicts.
- There are no Keep Separates only Documented Conflicts. If you say you have a conflict on a unit, you will be required to completely fill out a Conflict Form which will be fully investigated by the Intake Captain. (4/30/2019)

If you are having problems with your cellmate, please contact your Unit Officer or other security personnel





# Careers in Horticulture Lecture on 4/26/19

The third lecture in the series brought to Coffee Creek by the Sustainability Office and Institute of Applied Ecology will be held Friday April 26th in both the medium and minimum facilities.

Joleen Schilling, Professor and Program Chair for Horticulture at Chemeketa Community College, will present "Careers in Horticulture." This presentation will be about how horticulture is an important part of Oregon agriculture. There are a wide array of jobs available in the field of horticulture, from managing greenhouses to customer service, to hands-on management and landscaping work. Obtaining a degree in horticulture will teach you to perform skills and use equipment to care and grow plants in nurseries and greenhouses; recognize, name and understand management needs for plants grown in Oregon nurseries and greenhouses; know government regulations for nursery and greenhouse operations, work and pesticide safety, water regulations and crop sanitation; and evaluate production in terms of sustainability.

This lecture will be given by a Chemeketa Community College Horticulture Instructor, who will go over the many career opportunities and provide insights into the training necessary for getting a job in the varied field of horticulture.



This special talk will be held Friday April 26th, 1:00 pm to 2:00 pm in the medium Chapel and 2:30-3:30 pm in the minimum Dining Room, limited to 70 participants in medium. # Eyeglass Donations at Coffee Creek

Through a partnership with the Oregon Lions Hearing and Sight Foundation the Eyeglass-recycling program at Coffee Creek gladly accepts all types of eyeglass donations from our visiting guests. Please let your guests know that they'll find a donation box in both Medium Facility Access and Minimum Visitor Waiting Area.

Donated eyeglasses will be routed to the Minimum facility eyeglass-recycling program, where they will be refurbished, neutralized (the prescription will be read and recorded), and packaged for the Oregon Lions to take on Sight Missions all over the world.

The eyeglass-recycling program here at Coffee Creek was formed over 15 years ago as a partnership with the Oregon Lions Hearing and Sight Foundation. This program was created as a way for offenders to give back to the community by helping the Oregon Lions Foundation to recycle glasses that are dispensed all over the United States and other countries to people who may not be able to afford glasses or may not have the ability to obtain them. Currently we recycle over 6000 pairs of glasses a month for the Oregon Lions.

As the recycling program grew, Portland Community College along with Kelly Asbra, the Optical Programs Director of the Oregon Lions Sight and Hearing Foundation created an educational and vocational program that was the first of its kind in Oregon. Our education has been broken into three distinct areas of learning.

During the first part of the day the students study in a classroom setting, learning all aspects of optics. This includes lensometry, tools and adjustments, ophthalmic frames, lens materials, lens coatings, eye anatomy, medical terminology, math, basic principles, eye diseases, lens form and analysis, multi-focal and PALS. Students also study professional issues, basic science, clinical principles and procedures in ophthalmic dispensing for the Certified Paraoptometric Exam, which they take at the end of the year.

During the second part of the school day students are in Production. This is the part of the program where students recycle donated glasses to go out on sight missions through the Lions Foundation. During a typical day, students will be at different stations where they sort, wash, or dry glasses. From there, students read the prescriptions of the glasses and bag them for the missions. Students also learn to repair glasses for the missions, as well as for all of the institutions in Oregon. This includes replacing nose pads, temple tips, and general fitting adjustments.

Another aspect of the Eyeglass Program is our finishing lab. This lab fabricates and dispenses over 1300 eyeglasses a year to all the prisons in Oregon. Here, students learn how to read and process prescriptions for patients from all of the institutions in Oregon. This process involves checking lenses for scratches, finding and setting the prescriptions in the individual lenses, spotting, blocking, and finally cutting out the lenses to fit the patients frames. Once the lenses have been cut, our lab workers place the lenses in the frames, and recheck their work to make sure there are no scratches from handling, and that everything in the prescription is within tolerance standards set forth by ANSI.

Eyeglass is an amazing program to not only gain the tools needed to be successful in the optical field but it is also another way to give back to our community. By partnering with the Lions Sight and Hearing Foundation and providing numerous pairs of glasses that go on sight missions around the world, together, we help bring the gift of sight to those who do not have access to optical care.


