Columbia County Convictions only:

DOC has received a twenty-five-page document from Lake County District Attorney's Office, which explains their process for SB 819 applications. You may purchase a copy of this document from the Law Library. Please fill out a Law Library Request form (CD 1714) to be scheduled for a form's appointment. You will need to fill out a legal photocopy request form and CD 28.

For Curry County convictions only:

Curry County District Attorney's Office does not have a specific form that must be filled out in order for a request to be considered. Someone requesting review of their case should provide the following:

- o The conviction(s) underlying the sentence for which the requestor seeks a conviction or sentence reconsideration.
- o Whether the conviction is on direct appeal (if it is, the case is ineligible for consideration).
- o Reasons why the original sentence no longer serves the interests of justice.
- o The requestor's desired result: No conviction at all? Conviction of a different crime? Reduction of prison sentence? Reduction of fine? Etc.
- o Information that addresses the considerations listed in ORS 137.218:
- The requestors disciplinary record in jail or prison (if applicable) and record of rehabilitation while incarcerated.
- Evidence that reflects whether the requestor's age, time served in-custody, and diminished physical or mental condition, if any, have reduced the requestor's risk for future violence.
- The future safety of the victim of the crime(s) for which the requestor seeks conviction or sentence reconsideration.
- The amount of the original sentence already served by the requestor.
- Evidence that reflects changed circumstances since the requestor's conviction and shows that the requestor's sentence no longer advances the interests of justice

Requests can be mailed to: Curry County District Attorney, 94235 Moore St., Ste 232, Gold Beach, OR 97444.

Other than Columbia, Clatsop, Wasco, Lake, Marion. Coos, Jackson, Malheur, Grant, Klamath, Washington, Linn, Multnomah, Deschutes, Curry, Josephine and Lane County, DOC has no further information regarding SB 819. You will need to contact all other District Attorney's Offices for more information. We will update as we receive information from District Attorney's Office.

Please do not send CD-28 in the mail to the Legal Library. All CD-28s that are sent in the mail to the legal library will not be processed. AlCs will need to be scheduled on a callout for a forms appointment. AlCs will need to fill out a legal photocopy request form and CD 28.

Notary Reminder:

All items that are notarized need to be mailed out of the legal library. Please bring an envelope to your scheduled appointment.

Notice to AICs

In August I submitted the below article for the Walled Street Bulletin. There are a significant amount of drugs being caught by the mailroom every week at ODOC facilities which is causing the Department to look at the AIC mail process. Accidental exposure to particular narcotics or chemicals can be dangerous and deadly. If you have ideas that will help improve the efficiency and safety of the mail process, which would allow us to curtail dangerous contraband coming into the facility, please send them to Mr. C. Wagner, Assistant Superintendent of General Services.

The submission from August:

Unexpected "Special" Packages

There have been multiple incidents in which narcotics have been sent in the mail to allegedly unsuspecting recipients. In those cases, one of four things was happening:

- 1. The recipient was expecting the narcotics and is claiming ignorance as a defense
- The recipient knew the narcotics were coming but were being forced/coerced into being the recipient by others.
- 3. The recipient was not expecting the narcotics and is being used as a proxy or unwitting mule by somebody else, as a safety measure so the person receiving the drugs doesn't get caught. The person who received the mail would then be approached by whoever arranged to have the drugs sent in and told to hand them over.
- 4. The recipient didn't know the narcotics were coming and was being set up to be charged criminally or administratively with smuggling the drugs. Even if not charged, it would cause a disruption in programming and bring suspicion and scrutiny upon the recipient.

What can you do if you receive a letter or package you weren't expecting that has narcotics in it?

Discreetly surrender it to a staff member and explain the situation. The recommendation is to deal with the Housing Sergeant.

If the mailroom failed to catch the envelope with drugs in it, which you weren't expecting, surrender it to staff. The staff member will report it to the OIC, but it can be presented as "caught by the mailroom" while the issue is investigated. In the case of #2 or #3 above, if it was "caught in the mailroom" and you didn't know it was coming, the AICs using you as a mule without your knowledge don't have anything to hold against you. In the case of #4, turning in an unexpected letter with drugs hidden in it will be easier to defend regarding you not being a part of the smuggling operation and potentially being set up.

You must include the unused soda tickets and a receipt as proof of purchase. The receipt may not be more than 90 days old from the date of request. Commissary will not issue credit for damaged tickets or issue credit if the soda machine takes your ticket without dispensing a soda.

MHI Unit ADL/Peer Companion Position Announcement

We believe that inmates who have proven to be successful in the prison community can provide a valuable resource to peers within that community. By listening to and mentoring peers who are struggling with various disabilities, Peer Companions can help teach them how to more effectively and productively manage their own responses to their environment.

Mental Health Special Housing is now hiring for two, full-time ADL/Peer Companions on the Mental Health Infirmary (MHI) unit. The Individuals selected for this position will report to the MHI unit for their shifts. We are looking for motivated, responsible individuals who have the willingness to work with individuals unable to care for their own ADL's as well as individuals experiencing significant mental health symptoms. It is important for Unit Peer Companion candidates to behave in a manner that is respectful, safe, confidential, and honest; modeling patience, respectful

communication, and the following of all unit and institution rules.

MHI Unit ADL/Peer Companions will have specific shifts and are responsible for assisting unit staff, QMHP's and treatment staff in ensuring that identified inmates housed on MHI are getting their basic and daily needs met, which helps to improve their functioning and improve their overall quality of life while incarcerated.

Duties may also include assisting individuals around ADL coaching and skill building; increasing social interactions; and guiding or accompanying individuals who have difficulty walking or who are resistant to engaging in activities outside of their cells to activities on the unit, during day room, or out for MHI yard time. Please submit an application kyte to Kirsen Leep, MHI Program Manager if you are interested. Applications will be accepted until this position is full. To be eligible, you must be an incentive Level 3 and have clear conduct for at least one year, it is preferred that you have one or more years left on your sentence.



COVID-19 CONFIRMED CASES
