What is a DESIGNATOR?

7) **Designator:** Information, alerts or statutory designations important for sentence computation and crucial to determining work crew eligibility, minimum housing assignments, and the management of AIC's, both in institutions and in the community.

Examples of Designators:

- AIP Eligibility
- Detainers
- Escapes
- STM
- Short-Term Transition Leave Eligibility
- WHALE (minimum gate clearance): Unfenced/Community/Inside

***There are many more, but these are some of the examples that we see daily.

**Every AIC will have at least one designator: <u>AIP Eligibility (Yes or NO)</u>
This is a judgement from the Courts and needs to be determined prior to an AIC's assignment to a correctional facility.

The FAFSA Simplification Act, part of the Consolidated Appropriations Act of 2021, will expand eligibility for the federal Pell Grant to include incarcerated students. These students will be able to take advantage of the grant – which provides need-based aid to students from low-income households – by <u>July 2023</u>.

In recent years, AIC's interested in filing taxes has greatly increased. To save time, confusion and potential frustration on this topic, Library Services and Business Services paired up to develop a plan to address AICs requests for 2022 tax forms. We provided the verbiage below for inclusion in all AIC newsletters regarding taxes and tax forms. We also asked that the attached flyer (created and provided by Oregon Dept. of Revenue) be added to the newsletter. We've also requested that the attached pamphlet be added to AIC kiosks.

Business Services Staff are ordering one 1040 tax form for each Adult in Custody. Forms will be available on housing units on a first-come basis. If you are unable to obtain a form, need additional copies, or forms beyond a 1040, you will need to request the forms directly from Oregon Department of Revenue and/or the Internal Revenue Service. You may request forms in writing at the following addresses:

Please note: DOC staff are unable to provide tax advice or status updates.

Library Coordinators have been given instructions to allow one photo copy of completed tax forms. Indigent AICs will be allowed to incur debt on their trust account for the copy. We are requesting that you share this information with staff at your facility. Should you have any questions, please let us know.

Due to the possibility of another Covid outbreak within our Institutions we are preparing for potential temporary spending restrictions. We will be sending two commissary forms (regular and emergency) to your institution to be completed each week until further notice.

We will process your order either in full or with the least amount of restrictions possible; however, we will utilize the emergency form if needed. Having both forms will allow us to adjust with minimum interruptions to our customers.

We appreciate your cooperation and understanding once again as we navigate through this.

We are happy to say, as of today, NWC is getting a partial work crew. This allows us to move away from the Emergency Form and back to the regular order form starting next week (1/17/22); however, we will be at a \$25 spending limit until we are able to get a full crew.

Please remember, if you choose more than the \$25 on your order form it will be at the discretion of Commissary Staff what items will be processed so to ensure you get what is important to you keep your orders to \$25.

Though this is an improvement, we understand it is still not an ideal situation. These challenges are frustrating for us all and we continue to work on alternative solutions and appreciate your patience.

Reminder:

Please note that Commissaries statewide continue to see product orders shorted or items not being shipped at all with numerous production delays from manufacturers. We are continuing to work with each vendor to replenish stock on hand. Your patience is appreciated as we are working diligently to ensure all products are available.

Soda tickets will only be credited if an aic has been transferred to a different facility. The aic has 30 days from the date of transfer to submit an aic communication form requesting a credit from the commissary where the soda tickets were purchased. You must include the unused soda tickets and a receipt as proof of purchase. The receipt may not be more than 90 days old from the date of request. Commissary will not issue credit for damaged tickets or issue credit if the soda machine takes your ticket without dispensing a soda.



Prison Rape Elimination Act (PREA Information)

The Oregon Department of Corrections (ODOC) has a zero tolerance policy for sexual abuse, sexual harassment and for retaliation for reporting an incident. You may report in person to any staff, through an inmate communication, through the grievance system, by calling the PREA hotline by dialing 9 from any inmate phone.

Filing an Anonymous PREA Report

If you are uneasy about filing a PREA allegation, you may file an anonymous report with an outside agency.

Please indicate in the beginning of your letter you are filing a PREA allegation and you are requesting to remain anonymous. The Governor's Office will refer all anonymous allegations to the DOC PREA Coordinator to assure an investigation is completed based off the information that is provided.

Community-Based PREA Advocacy (Support) Program

ODOC has partnered with community based, confidential advocates of sexual abuse victims to provide services to inmates.

Inmates at ODOC who have experienced sexual abuse may reach a community-based advocate by dialing 711 inmate telephone systems, or may request a private call through the PREA Compliance Manager at the facility. Advocates provide victims of sexual abuse information about their options, resources, information and emotional support. There is no charge for calls to advocates.

Role of an Advocate:

- Provide confidential support and crisis intervention
- Inform you about the investigation and medical examination process
- Educate you about healing from sexual abuse
- Offer resources and referrals

Advocates will:

- » Not tell you what to do
- Not communicate with the institution unless you request them to do so and sign a release
- Not provide legal advice

Community-based advocacy centers provide sexual abuse support to people of all genders. Community-based advocates will not report unless you request them to do so and if you sign a release of information.

DOC is committed to providing inmates with avenues to seek assistance. Below are additional resources:

The community-based advocacy crisis line is for individuals needing assistance coping with sexual abuse related issues and should not be used for other purposes.

Telephone calls and mail with community-based advocacy centers is considered privileged communication and will be handled similar to legal calls/official mail.

Do I need to file taxes while I'm in prison?

The same rules for filing a tax return that apply to you outside of prison still apply while you're in prison. You must file a tax return if your gross income* for the tax year is over the filing requirements set by law (see chart below).

For example, a tax return may be necessary if you:

- Worked part of the year and were in prison part of the year.
- Received income while in prison, such as: retirement income, investment income, or alimony payments.

Taxable income

These are examples only. For complete information, see IRS Publication 525

- Employee compensation such as wages, salaries, commissions, fees, and tips.
- Miscellaneous compensation such as bonuses, severance pay, and sick pay.
- S corporations, self-employed) (see IRS Business income (partnerships, Publications 541 and 334).
- Unemployment benefits.
- Alimony received (see IRS Publication 504).
- Retirement income (distributions, pensions, annuities) (see IRS Publication 575)
- Investment income (interest, dividends, capital gains) (see IRS Publication 550).
- Gambling winnings.
- Publication 915) (Social Security isn't taxed by Oregon, but may be taxed by the IRS). Some Social Security benefits (see IRS
- Rental property income (see IRS Publication 527)

^{*} Gross income is all income you receive in the form of money, goods, property, and services, unless that income is nontaxable.

How to File


Tips for Filing

- Get the appropriate forms and instructions (such as IRS Form 1040 and Oregon Form OR-40) from a trusted source. The institution is unable to provide these forms.
- You may appoint a qualified person as your power of attorney (POA) and have them file your tax return for you. Make sure to choose a person you trust to be your POA.
- Don't disclose your Social Security number (SSN) to others or let someone use your SSN for fraud. If fraud occurs, it will take a lot of work for you to clean up your account once you're out of prison.
- Request your W-2 from your employer if you didn't receive it.
- The award amount you receive from the Oregon Department of Corrections as an adult in custody is taxable income. You will receive Form 1099-MISC if your award totals exceed \$600.
- Be aware that the award amount you receive from the Oregon Department of Corrections as an adult in custody doesn't qualify as earned income when calculating your Earned Income Tax Credit.
- If you have a filing requirement, file or request an extension by April 18, 2022.



Processing: What's the Deal?

Statewide, an average of 175,000 pieces of mail pass through the Mail Processing Centers each month. Each incoming item must be sorted, tagged (with the AIC's housing unit), inspected (inside and out), and routed to the housing unit. This process generally takes less than 48 hours. Items such as those listed above can cause significant delays, or even cause the mail to be returned-to-
