- Amends the rules to align with current practices, fee schedules and terminology.

291-105 Prohibited Conduct

- Amends the rules to add exceptions around DSU sanctions for BHU status AICs.
- Effective: 3/28/2022

291-124 Health Services (AIC)

- Amends the rules to add language to allow a Medication-Assisted Treatment (MAT) pilot program.
- Adopts fee schedule for release of AIC health records in accordance with statute.
- Effective: 4/21/2022



USPS CONTINUES TO HAVE DELAYS.

<u>IF YOU HAVE ITEMS THAT MUST ARRIVE BY A CERTAIN DATE, ALLOW EXTRA TIME.</u>

(A LOT of extra time.)

USPS delivery times are very inconsistent. Some items arrive in a few days, and some not for two weeks. How long your item will take for delivery is out of our control.

USPS sends all mail to their Portland distribution center.

USPS mail sent from Salem to Salem, will go up to Portland and back to Salem.

In addition, USPS does not pick up, or deliver, mail to OSP.

DAS (Dept of Administrative Services) handles all USPS mail/interactions with USPS.
