#### Prison Rape Elimination Act (PREA Information)

The Oregon Department of Corrections (ODOC) has a zero tolerance policy for sexual abuse, sexual harassment and for retaliation for reporting an incident. You may report in person to any staff, through an AIC communication, through the grievance system, by calling the PREA hotline by dialing 9 from any AIC phone.

Filing an Anonymous PREA Report

If you are uneasy about filing a PREA allegation, you may file an anonymous report with an outside agency. You may write to:

Please indicate in the beginning of your letter you are filing a PREA allegation and you are requesting to remain anonymous. The Governor's Office will refer all anonymous allegations to the DOC PREA Coordinator to assure an investigation is completed based off the information that is provided.

Community-Based **PREA** Advocacy (Support) Program

ODOC has partnered with community based, confidential advocates of sexual abuse victims to provide services to AICs.

AICs at ODOC who have experienced sexual abuse may reach a community-based advocate by dialing 711 AIC telephone systems, or may request a private call through the PREA Compliance Manager at the facility. Advocates provide victims of sexual abuse information about their options, resources, information and emotional support. There is no charge for calls to advocates.

Role of an Advocate:

- >> Provide confidential support and crisis intervention
- Inform you about the investigation and medical examination process
- Educate you about healing from sexual abuse
- Offer resources and referrals

Advocates will:

Not tell you what to do

- > Not communicate with the institution unless you request them to do so and sign a release
- Not provide legal advice

Community-based advocacy centers provide sexual abuse support to people of all genders. Communitybased advocates will not report unless you request them to do so and if you sign a release of information.

The community-based advocacy crisis line is for individuals needing assistance coping with sexual abuse related issues and should not be used for other purposes.

Telephone calls and mail with community-based advocacv considered centers is privileged communication and will be handled similar to legal calls/official mail.

#### Ley de Eliminación de la Violación en Prisión (Información PREA)

El Departamento de Correcciones de Oregón (ODOC) tiene una política de tolerancia cero para el abuso sexual, el acoso sexual y las represalias por denunciar un incidente. Puede informar en persona a cualquier personal, a través de una comunicación de AIC, a través del sistema de quejas, llamando a la línea directa de PREA marcando 9 desde cualquier teléfono de AIC.

Presentación de un informe prea anónimo

Si se siente incómodo al presentar una acusación de PREA, puede presentar un informe anónimo ante una agencia externa.

Indique al principio de su carta que está presentando una denuncia de PREA y que está solicitando permanecer en el anonimato. La Oficina del Gobernador remitirá todas las acusaciones anónimas al Coordinador de DOC PREA para garantizar que se complete una investigación basada en la información que se proporciona.

Programa de Defensa (Apoyo) de PREA Basado en la Comunidad

ODOC se ha asociado con defensores confidenciales y basados en la comunidad de víctimas de abuso sexual para proporcionar servicios a AICs.

Los AlCen ODOC que han experimentado abuso sexual pueden comunicarse con un defensor basado en la comunidad marcando los sistemas telefónicos 711 AlC, o pueden solicitar una llamada privada a través del Gerente de Cumplimiento de PREA en la instalación. Los defensores brindan a las víctimas de abuso sexual información sobre sus opciones, recursos, información y apoyo emocional. No hay cargo por llamadas a defensores.

Papel de un defensor:

- Proporcionar apoyo confidencial e intervención en crisis
- Informarle sobre el proceso de investigación y examen médico
- > Educarlo sobre la curación del abuso sexual
- → Ofrecer recursos y referencias

Los defensores:

- » No te digo qué hacer
- No comunicarse con la institución a menos que usted solicite que lo hagan y firmen una liberación
- No proporcionar asesoramiento legal

Los centros de defensa basados en la comunidad brindan apoyo contra el abuso sexual a personas de todos los géneros. Los defensores basados en la comunidad no informarán a menos que usted les solicite que lo hagan y si usted firma una divulgación de información.

El DOC se compromete a proporcionar a los reclusos vías para buscar ayuda. A continuación se presentan recursos adicionales:

If you put the items listed above in the Group Living Mailbox, they will eventually make it to their final destination; however, it will take more time. To insure your communication makes it to its correct destination in a timely manner, please place it in the correct mailbox for routing.

Haircuts:



Haircuts are available upon request. Group Living haircuts are available to all AICs. This is a barbering school as such and someone in training may cut your hair and they may struggle to do exactly what you request, but they will do their best. Please do not wait for a particular barber; all of our barbers need to practice and learn to cut hair for all types and styles. We have lead barbers to assist if the barber cutting your hair struggles. Please limit your request to once per month to allow everyone an equal opportunity.

Curling Irons and/or Flat Irons:

Curling irons and flat irons are available for use in Group Living. If you wish to use this service, please send an AIC Communication Form to Group Living/curling iron to be scheduled on the next available day. AICs are authorized to use this service twice per week. You may bring and use your own hair styling products. Hairstyles that bring undue attention to an individual are not allowed.

#### Housing:

Convenience Moves: To qualify for a convenience move, you are expected to participate in acceptable work/program assignment and demonstrate appropriate acceptable institution conduct. Requests for cell changes must be submitted to the Group Living Captain and all AICs involved must sign the request. All requests will be reviewed and considered for approval. The safety, security, and orderly operation of the institution is our first priority and will be considered before an approval is made.

NCI levels 1 and 2 are authorized to move every 90 days.

NCI level 3 is authorized to move every 30 days.

AICs are authorized 4 moves per year.

When completing a Cell Assignment Request Form or an AIC Communication Form, please make sure to include your full name, SID#, and your current block and cell number. (Example: D-201A not 201A)

#### Safety and Wellness:

Sanitation throughout the institution and your personal hygiene determines your health and the health of the general population by reducing pest infestation and the transmission of communicable disease. Practicing sanitation on a daily basis will benefit you for the rest of your life.

Cell sanitation is an important part of good hygienic practice. Your sink, toilet, floor and all other areas of your cell need to be kept clean at all times; your trash should be emptied daily. These practices will help reduces infestation and fire hazards and makes for more tolerable living conditions.

#### **Evening Winter Activities 2022**

The Evening winter activities will begin Monday October 3, 2022.

Scheduling will be in three groups on a rotating basis:

- 1. E-Block

Blocks rotate every third night starting with E-Block on Monday October 3, 2022. Only AlCs living in the scheduled block(s) may attend.

The following procedures will be in effect:

- 1. A line for the evening activities will be ran from the eligible housing units to the Recreation Yard Building at 7:00 p.m. This will be the only line out. Evening yard ends at 9:00 p.m.
- AICs will go down the main avenue and enter the Recreation Yard through electric gate #9 at the southwest corner of the basketball court. Security will not allow anyone to remain outside the Recreation Yard Building.
- 3. If a block has Winter Evening Activities and Evening Showers on the same night, those AICs can go to the Recreation Yard directly after their showers (you may not return to your housing unit first). These persons go directly to the Recreation Yard Building through the Security Gate and continue through electric gate # 3.
- 4. The Card Room, Basketball Court, Pool Room, and showers will be open.
- The television in the Card Room is only for movies.The sports television is for sports viewing except


on minority viewing nights (Tuesday, Wednesday, and Thursday).

6. Security calls optional one-way Cell/Pill Line at 8:00 p.m. There will be no returning to the yard from this line.

# CORRECTIONAL REHABILITATION



#### Visiting Room

If you have been in the Visiting Room in the last week, you have probably seen the new addition of an aquarium. You will notice this is not your usual fish tank. The Oregon State Penitentiary has been blessed to have the opportunity to be part of the Oregon Department of Fish and Wildlife's Salmon and Trout Enhancement Program (STEP)- Fish Eggs to Fry Program.

On Wednesday, 220 Spring Chinook Salmon "eyed eggs" were gently placed in their new gravel environment to incubate. Some of the program's goals are to show how sensitive the fish are to ecological changes, the difficulties they face in the wild and biological/physiological development of the species.

In the weeks ahead, you will see AICs taking daily temperature readings that will be used to calculate temperature units (TU). Temperature units are used to predict when eggs will hatch and how long it will be until the fish are mature. You and your children will have the opportunity to learn firsthand about the life cycle of fish while observing the eggs hatch and transforming into "sac fry" before becoming tiny salmon. There will be lots of fun facts and activities to participate in.

Salmon are not the only new things for the Visiting Room. A variety of toys, games, books, and educational materials have been purchased. Prior to the conclusion of the visiting session, please take the time to properly put away and return the items you are using during your visits, so others have the chance to enjoy them.

#### Apprenticeship Program – Physical Plant Painter

The Physical Plant is now accepting applications for an open apprentice position in the Paint Shop. Eligibility requirements:

- Four years or more left until release.
- High School Diploma or GED equivalent.
- \$300 per year for three years (contract of \$25 per month or you may pay in full for one year).
- 12 months clear conduct minimum (longer clear conduct the better).
- Working at least 40 hours per week. Overtime is mandatory for apprentices.

#### Recommended or desired skills:

- Able to lift 50-75 pounds frequently.
- Reliable attendance (6000 on-the-job training hours required for program completion).
- Experience using hand tools, paint brushes, rollers, and knowledge of simple power tools.

### MHI Unit ADL/Peer Companion Position

We believe that AICs who have proven to be successful in the prison community can provide a valuable resource to peers within that community. By listening to and mentoring peers who are struggling with various disabilities, Peer Companions can help teach them how to more effectively and productively manage their own responses to their environment.

Mental Health Special Housing is now hiring for two, full-time ADL/Peer Companions on the Mental Health Infirmary (MHI) unit. The Individuals selected for this position will report to the MHI unit for their shifts. We are looking for motivated, responsible individuals who

have the willingness to work with individuals unable to care for their own ADLs as well as individuals experiencing significant mental health symptoms. It is important for Unit Peer Companion candidates to behave in a manner that is respectful, safe, confidential, and honest, modeling patience, respectful communication, and the following of all unit and institution rules.

MHI Unit ADL/Peer Companions will have specific shifts and are responsible for assisting unit staff, QMHPs and treatment staff in ensuring that identified AICs housed on MHI are getting their basic and daily needs met, which helps to improve their functioning and improve their overall quality of life while incarcerated.

Duties may also include assisting individuals around ADL coaching and skill building, increasing social interactions, and guiding or accompanying individuals who have difficulty walking or who are resistant to engaging in activities outside of their cells to activities on the unit, during day room, or out for MHI yard time.
