- AIC Requirements: Items listed below must be met:
- AIC verifies visit with approved visitors / family
- AIC picks date for Visiting Cookie Event 2 weeks in advance of visit
- AIC submits Communication form / Approved CD28 to M Vokral 2 weeks prior to predicted visit
- AIC will be notified of approval or denial for Family Cookies Event. NSF's and Denials will be returned to AIC.
- All requests will be filled in good faith. If a visit is a "no show" refund will not be approved. If visitors are unable to attend and we are notified at least 5 days prior to scheduled date, refunds will be allowed.
- Cookies must be consumed by the AIC and visitors in the visiting room. Cookies cannot be taken to AIC housing

Price Increases Effective 2/17/2023:

Our vendors are working hard to keep prices as low as possible but unfortunately inflation is hitting everyone as cost of goods and transporting goods continues to skyrocket. Price increases are inevitable, as in this case, we were notified the cost of the following items have been increased.

Commissary has absorbed multiple increases on soups and a large increase with the last shipment and it is necessary for commissary to increase the current Ramen soup price.
