SPRING/SUMMER MENU

SRCI Physical Plant has an AIC Journeyman Electrical Apprenticeship position that will be available in the near future. In order to apply, all of the following criteria must be met (no exceptions):

- Clear conduct (No Major DR or Program Failures)
- Completed and passed Math 70 or above (Must show proof)
- High School Graduate, GED, or above
- Must be eligible to be housed in Complex 1A, 1B, 1C or Minimum
- Classification 3 or less
- No history of escape or arson
- 5-10 years remaining on sentence

This program takes approximately five years to complete (8,000 program hours). If you are interested in this program and meet all of the above requirements, send a completed job application along with an Inmate Communication expressing your interest to Physical Plant (B344). The applications will be screened by members of the SRCI Journeyman Electrical Apprenticeship Subcommittee. Qualified applicants will need to pass a security screening before being contacted for an interview. Applications will be accepted until May 18, 2023.

Visiting application form CD 50 needs to be sent to your perspective visitor and your visitor needs to send it to the address at the <u>BOTTOM</u> of the form. Do not send it through the inmate communications (kyte) mail system to SRCI visiting staff. If that happens, the application form will be returned to you.

River Correctional Institution.

Students Learn How to:

- 3. Frame a Structure with Wood and Metal Framing
- 4. Frame Stairs with a Hand Rail
- 5. Install Windows and Doors
- 6. Install Exterior siding, Roofing Materials, Flashing and More
- 7. Install House Wrap, Vapor Barriers and Insulation
- 8. Install Drywall & Drywall Finishing Techniques
- 9. Install Interior Trim & Bi-fold Doors

- 12. Work with Surveying Instruments

Requirements:

- 1. G.E.D. or High School Diploma
- 2. 7 years or less on sentence (exceptions can be made on a case to case basis)
- 3. No ESCAPE history
- 4. No ARSON charges
- 5. Minimum of 9 months housed at SRCI
- 6. Minimum of 9 months clear conduct
- 7. Must live or be willing to move to Complex 2

<u>You will</u> earn a 1 year certificate upon successful completion of the BCT program. <u>You will</u> earn 48 college credits which are in association with T.V.C.C. and the National Center for Construction Education and Research (N.C.C.E.R.). This program is nationally accredited and recognized.

If you are unaware of your Incentive level, please contact a Counselor or your Housing Unit Officer prior to the event to help mitigate confusion and uncertainty if you are authorized to attend.

If you are not an incentive level three at the time of the event you will not be allowed to participate, there will be no exceptions.

We encourage you to continue your goals to become a level 3 so that you may participate if we ever do this again. We are proud of your hard work and look forward to celebrating your success!!!

Apply by acquiring a Call Center Application from your housing unit. Make sure to check that you meet the Call Center criteria.

To qualify you need to meet the following criteria:

- Need 4 months of clear conduct- <u>IMU releases and multiple DR's require One year clear</u> (program compliant, attitude/behavior and work history are included in the criteria checks)
- Cannot have any ID theft charges. (some over 10 years are considered based on the severity)

Cannot be in any program or recreational callouts that would conflict with a 7:20am to 3:40pm work week.

Telephone agent's start at_11PRAS points + a Team Goal Award match (DBL PRAS)

You are also eligible to receive a nice added bonus from the private company you go to work for.

<u>Call Center work hours:</u> Mon-Fri 7:20am –report to work, at count clear (12-12:15) - Lunch (separate from general population), 3:40pm – release from work.

COVID-19 Vaccine and Booster Dose Update - April 2023

The COVID-19 virus is still present in our institutions and communities, and vaccines continue to be the safest and most effective way to protect from COVID-19 infection. The Food and Drug Administration (FDA) has released new guidelines on COVID-19 vaccine protocol. Health Services will be compiling a list of individuals who are eligible for a booster dose and will hold vaccination clinics for individuals who meet the criteria as established by the Food and Drug Administration.

If you are not yet vaccinated and would like to be, please contact Health Services. If you do not wish to be vaccinated, or receive boosters, you can opt-out.

What you need to know:

- At this stage of the pandemic, the FDA is simplifying the use of the authorized single mRNA bivalent COVID-19 vaccines (the monovalent mRNA vaccines are no longer being used).
- Most unvaccinated individuals may receive a single dose of a bivalent vaccine, rather than multiple doses of the original monovalent mRNA vaccines.
- Most individuals who have already received a single dose of the bivalent vaccine are not currently eligible for another dose.
- Individuals 65 years of age and older who have received a single dose of a bivalent vaccine may receive one additional dose at least four months following their initial bivalent dose.
- Most individuals with certain kinds of immunocompromise who have received a bivalent COVID-19 vaccine may receive a single additional dose of a bivalent COVID-19 vaccine at least 2 months following a dose of a bivalent COVID-19 vaccine.
- Health Services is compiling a list of individuals eligible for a second dose.

Actualización de Dosis de Refuerzo y Vacuna COVID-19: Abril de 2023

El virus COVID-19 todavía está presente en nuestras instituciones y comunidades, y las vacunas continúan siendo la forma más segura y efectiva de protegerse de la infección por COVID-19. La Administración de Alimentos y Medicamentos (FDA) ha publicado nuevas pautas sobre el protocolo de la vacuna COVID-19. Los Servicios de Salud (Health Services) compilarán una lista de personas que son elegibles para una dosis de refuerzo y realizarán clínicas de vacunación para las personas que cumplan con los criterios establecidos por la Administración de Alimentos y Medicamentos.

Si aún no está vacunado y le gustaría estarlo, comuníquese con los Servicios de Salud. Si no desea ser vacunado o recibir refuerzos, puede optar por no hacerlo.

Lo que necesitas saber:

- En esta etapa de la pandemia, la FDA está simplificando el uso de las vacunas COVID-19 bivalentes de ARNm único autorizadas (las vacunas de ARNm monovalente ya no se usan).
- La mayoría de las personas no vacunadas pueden recibir una dosis única de una vacuna bivalente, en lugar de dosis múltiples de las vacunas de ARNm monovalentes originales.
- La mayoría de las personas que ya recibieron una dosis única de la vacuna bivalente actualmente no son elegibles para otra dosis.
- Las personas mayores de 65 años que hayan recibido una dosis única de una vacuna bivalente pueden recibir una dosis adicional al menos cuatro meses después de la dosis bivalente inicial.
- La mayoría de las personas con ciertos tipos de inmunodepresión que han recibido una vacuna bivalente contra el COVID-19 pueden recibir una sola dosis adicional de una vacuna bivalente contra el COVID-19 al menos 2 meses después de una dosis de una vacuna bivalente contra el COVID-19.
- Servicios de Salud está compilando una lista de personas elegibles para una segunda dosis.
