AIC PHOTOS (as of May 4, 2023)

Photos have been approved on the yards and gyms. You may take photos with your friends. Up to four AICs in the photo, and masks are not to be worn. The purchasing AIC must be in the photo. Photos may only be purchased with a CD28 that is signed by you and STAMPED and INITIALED by your unit officer. There are no "photo tickets". During your yard time, take your CD28 out to the yard when you want a photo taken, and give the CD28 to the AIC Photographer. The account is #2596.

• \$2.00 4x6 double print

- \$2.50 5x7 single print
- \$4.00 8x10 single print

Three photos are the limit per day. Please note that it takes four to five weeks to receive your photo from the time you take it. Account #2596. CD28s can take a few days or up to two weeks to process.

Photos may be taken against a blank wall or bleachers in the gyms. No ceilings, cameras, doors or windows in the photo. No signs, posters or papers on the wall in the photo setting. Photos will not interfere with or hold up the activities. No AICs or staff or anyone in the background. No loose clothing. No briefs showing (not even a little bit). No wearing gloves. No security threat tattoos, hand signals or other stances related to security threat activities. In the yards, the locations are known by the photo clerks. Photos must be located so none of the following is showing fences, razor wire, towers, roof lines, cameras, bulletin boards or posters, etc. In the Complex 3 yard, photos may be taken at the retaining wall near the basketball courts. No photos on the steps by Complex 3 Units E, F, G, or H.

If an AIC breaks any rules in the photo, the photo will be confiscated, and no refund given. The AIC will not get the photo or the refund. The AIC purchasing the photo is responsible to ensure that the photo is acceptable, and all rules are adhered to. Questions: Mr. J. Saunders, Photo Coordinator, Box #B339.

Apply by acquiring a Call Center Application from your housing unit. Make sure to check that you meet the Call Center criteria.

To qualify you need to meet the following criteria:

- Need 4 months of clear conduct- IMU releases and multiple DR's require One year clear (program compliant, attitude/behavior and work history are included in the criteria checks)
- Cannot have any ID theft charges. (some over 10 years are considered based on the severity)

Cannot be in any program or recreational callouts that would conflict with a 7:20am to 3:40pm work week.

Telephone agent's start at_11PRAS points + a Team Goal Award match (DBL PRAS)

You are also eligible to receive a nice added bonus from the private company you go to work for.

Call Center work hours: Mon-Fri 7:20am – report to work, at count clear (12-12:15) - Lunch (separate from general population), 3:40pm – release from work.

A letter from the Corrections Ombudsman:

The Corrections Ombudsman has the power: to investigate, on complaint or on the Ombudsman's own motion, any action by the Department of Corrections (DOC) or any employee thereof without regard to its finality. However, pursuant to ORS 423.425, the Ombudsman may decide not to investigate complaints that are trivial, frivolous, vexatious, or not made in good faith, as well as those that are too long delayed or could reasonably be expected to be resolved through a different administrative process.

The position is located within the Governor's Office and is not accountable to and does not report to the DOC in any manner. All communications to the Ombudsman are confidential and no person who files a complaint to the Ombudsman pursuant to ORS 423.400 to 423.450 shall be subject to any penalties, sanctions or restrictions because of such complaint. If any person willfully obstructs or hinders the proper and lawful exercise of the Ombudsman's powers, or willfully misleads or attempts to mislead the Ombudsman in inquiries under ORS 423.400 to 423.450, a Marion County Circuit Court judge, on application of the Ombudsman, shall compel obedience by proceedings for contempt.

Because the modern version of this position is new, it will take some time to establish the office and build the Ombudsman team. While I am processing and replying to all complaints, please be advised that this is a very slow process.
