### SECURITY



#### Hygiene Rule Review

Ensuring the safety of everyone living and working at OSP is our top priority. Staff will address anyone who is dressed in a manner that draws undue attention or compromises safety and security as outlined in the 'Hygiene, Grooming and Sanitation (AIC)' rules 291-123-0015:

- (5) Clothing:
- (a) Adults in custody will be issued DOC clothing that is properly fitted, durable, presentable, and suitable for the activity in which the adult in custody may be involved.
- (b) Adults in custody must be properly attired in a manner that does not draw undue attention or compromise internal order and discipline, institutional security, or the health and safety of the adult in custody, other adults in custody, and staff.

### **GENERAL SERVICES**

#### **Food Theft**

Food theft from Culinary is a major problem for the Institution. It impacts our ability to ensure adequate portions of the published menu are available, jeopardizes the health of individuals taking perishable food that is not being properly stored or cooked. It also has a significant effect on our ability to work within our food service budget.

This notice constitutes a direct order that you are not to take any food items from the Kitchen other than uncut fruit in the quantity served (per your AIC Handbook). The following plan was designed to address this issue in a reasonable, consistent way.

 If an AIC is caught stealing, or attempting to steal food, the food will be confiscated and disposed of accordingly. If the value of the food is less than \$20, the AIC will be issued a minor misconduct report. The minor misconduct report will be for disobedience of an Order III and will include the cost of all food items that must be disposed of due to the theft/attempted theft or misuse. If the value of the food is \$20 or more, the AIC will receive a major misconduct for Contraband II, and will also be charged for the cost of food that must be disposed of.

- 2. If the AIC stealing the food is assigned to the Kitchen or Dining Room, they will receive a program failure along with the Misconduct Report.
- This process will be used for foodstuff found outside the Culinary Section (for example cell searches, etc.) if the items can reasonably be determined to have been taken from the Food Services.

Note: This does not prevent a staff member from issuing a misconduct report for a higher level charge (Contraband II) in the event the AIC has received a recent minor misconduct previously for the same conduct.

### Prison Rape Elimination Act Questions and Answers

Here are the most asked questions when it comes to PREA:

- How can I report a PREA allegation?
   Answer: You can report an allegation to any staff member, the OIC, PREA grievance, PREA hotline, AIC communication and by third party.
- 2. If I use the PREA hotline or advocacy hotline are my calls confidential?

Answer: Yes, once you enter your pin number and press 9 for the PREA hotline or 711 to talk to a victim advocate, the phone system will not record the conversation or log that the number was called.

- 3. What is the buzzer sound I hear in all housing blocks, units and infirmary?
  - Answer: That buzzer sound is to make all AICs aware a staff member of the opposite gender has entered the area.
- 4. Is there a resource outside of the institution I can talk to about PREA confidentially?

Answer: Yes, the Center for Hope and Safety is an advocacy group that is there for you 24/7.

The role of the advocate is to:

Amplify the victim's voice
Redirect victim blaming
Provide emotional support
Explain options for reporting
Help victim process decision (not guide,
recommend or suggest what is right)
Provide resources and referrals
Sit through forensic exam / investigatory interview if
desired by the victim.
Support family and friends of the victim.

You can reach the advocate by dialing 711. The calls are confidential, not logged or recorded.

### Obstruction of View into Cell or Bunk Area

Nothing will be placed on or attached to cell bars. Nothing will be hung or placed in a manner that would obstruct the officer's view into the cell or bunk area.

This applies to celled housing units as well as the Dorm. Clothing, towels, sheets, and bedding are to be used for their intended purposes only, they are not to be hung around the bunk area to create curtains or obstruct view in the bunk or cell. Those in violation are subject to progressive discipline and confiscation of inappropriately used items. In the dorm, there is nothing allowed to be attached to the windows that would obstruct the view into the housing unit.

#### Property

There are still several AICs that are not in compliance with the amount of authorized property in their cells. There are property bins located on every block that are utilized to measure property. Any property that does not fit in that bin (with the exception of medical equipment, keyboard, guitar, and state-issued clothing/bedding) is considered excessive. Property must comply prior to moving cells. Those with excessive property will be denied convenience moves

until property is reduced. Excessive property shall be mailed out at the AIC's expense or discarded. Excess property that is not mailed out or discarded at the direction of staff will be considered contraband and may result in confiscation of the item(s) and/or disciplinary action.

Nothing will be taped, pasted, glued, or added to the cell walls. Nothing may be hung on the ceiling. Nothing may be hung on or interfere with the function of the fire systems (detectors, sprinklers, alarms, panes etc.). Items hung in the approved bulletin/cork board area may not exceed the area of the frame and items may not overlap.

#### Envelopes and Postcards

You are to immediately write your name and SID number on your envelopes/postcards (in ink) within the first hour after receiving them from Canteen. All blank or altered envelopes/postcards will be confiscated and those in possession are subject to disciplinary action.

#### **ICH Unit Peer Companion Position**

We believe that AICs who have proven to be successful in the prison community can provide a valuable resource to peers within that community. By listening to and mentoring peers who are struggling with various disabilities, Peer Companions can help teach them how to more effectively and productively manage their own responses to their environment.

Mental Health Special Housing has several Peer Companion positions open on the Intermediate Care Housing (ICH) unit. The Individual selected for this position will report to the ICH unit, yard, and/or treatment lounge for their shifts. We are looking for motivated, responsible individuals who have the willingness to work with both our elderly and special needs population. It is important for Unit Peer Companion candidates to behave in a manner that is respectful, safe, confidential, and honest, modeling patience, respectful communication, and following of all unit and institution rules.

ICH Unit Peer Companions are responsible for assisting unit staff, QMHPs and treatment staff in ensuring that identified AICs housed on the ICH are getting their basic and daily needs met, which helps to improve their functioning and improve their overall quality of life while incarcerated.

Duties also include escorting individuals to appointments, assisting individuals in groups, working with individuals who have difficulty walking or who are resistant to engaging in activities outside of their cells, cleanliness of their cell, and offering peer support to individuals with severe mental illness.

To be eligible, you must be an incentive Level 2 or higher and have clear conduct for at least one year. It is preferred that you have one or more years left on your sentence. Compensation is maxed out at 18 PRAS points, working a five-day work week.

New Ethnicity Field

Pursuant to SB 1510 (2022), the Oregon Criminal Justice Commission (CJC), in conjunction with the Oregon Department of Corrections (ODOC), is required to collect and report data concerning:

- the number of persons on supervision;
- persons revoked from supervision and sentenced to incarceration; and
- persons sanctioned for violating conditions of supervision and serving a sanction in a local correctional facility.

CJC will review and disaggregate this data by race, ethnicity, gender, and county. CJC will make this data available to the public.

For this purpose, ODOC has added an ethnicity field which will appear in the DOC400 in the offender's description screen and will show on an Adult-in-Custody's (AIC) ODOC facesheet. This programming will become <u>effective November 15, 2023</u>. The available options will be Hispanic (H), or Non-Hispanic (N), or Unknown (U). This information will be collected by the appropriate county community corrections agency for persons beginning a supervision sentence, and upon admission to the ODOC Intake Center for those serving a prison sentence. If the AIC declines to select one of the two options, unknown (U) will be used.

In addition, current AICs may request to add their ethnicity to their ODOC's record. To request this, the AIC shall forward an AIC Communication Form (CD 214) to their institution's records office for processing. Any questions regarding this process may be directed to the Offender Information and Sentence Computation Unit.

Subject: 2023 Holiday Period

The 2023 Holiday Period begins Monday, November 27, 2023, and goes through Friday, December 29, 2023. During this time, for AICs with DOC debt and external obligations, the following parameters will be in place:

#### **DOC Debt and External Obligations**

- DOC debt (examples: disciplinary fines, copy, and postage debt) will be collected through Wednesday, November 22, 2023, prior to the start of the Holiday Period.
- During the Holiday Period, Central Trust will not collect existing DOC debt.
- External obligations (non-DOC debt) such as court filing fees (County / U.S. Court), garnishment
  orders, and Court-Ordered Financial Obligations (COFOs) will continue to be collected as DOC
  does not have the authority to suspend statutory collections.
- DOC debt collection will resume in the event an AIC receives a new disciplinary fine sanction during the 2023 Holiday Period.
- At the conclusion of the 2023 Holiday Period, on Friday, December 29, 2023, any funds remaining in the General Spending Trust Account of AICs with DOC debt will be collected in accordance with OAR 291 Div. 158-0065(d).

#### Spending Funds During the Holiday Period

- Commissary spending limits will be doubled.
- AlCs who have DOC debt may spend funds during the 2023 Holiday period from their General Spending Trust Account for the following: postage, copies, institution club & DOC activities, DOC programs, phone transfers, and commissary items.
- AICs with DOC debt cannot make external purchases or disbursements from their General Spending Trust Account during the 2023 Holiday Period.
- AICs should plan accordingly when submitting financial requests, such as commissary orders and Request for Withdrawal of Funds forms (CD28).

#### **Other Considerations**

- All plans are subject to staffing, and AIC commissary worker / supply chain availability.
- Transitional Savings deductions will continue to take place in accordance with ORS 423.105

The Holiday Period occurs at the discretion of the Assistant Director of Operations in accordance with OAR 291 Div. 158-0065(d). AICs with questions may submit an AIC communication to Business Services (electronic option available on the tablet).
