

Hearing Notice from the Court

What do I do as an AIC that receives a Hearing Notice?

Unable to contact the court with the phones here Contact staff here.

The best way to be able to proceed:

Contact family/friends and give them the information on the Hearing Notice:

Contact number on the Hearings Notice – SCI is conducting phone calls (at this time)

Give the case number, your full name and SID# to your contact, THEN your contact

can call the court. They can give out the SCI staff information in the next step

Give your contact (Family/Friend) the staff contact (Ms. Garibay 503-378-2964) OR

DOC website for professional calls (follow prompts under SCI section)

#### What happens next?

The Court contacts Ms. Garibay to schedule
Call-out is entered & a reminder kyte sent
Complete your call in assigned location (Unit 2 call room)

Do I need to follow-up and send a kyte to staff?

If you receive another Hearings Notice from the courts, the process will need to be repeated.

Sometimes you may need to call/ write your attorney, not staff.

#### Legal Libraries and thumb drive storage

Library Services issues DOC thumb drives for AIC use for saving and storing legal documents only. Legal documents are defined in OAR 291-139-0110 (10). In accordance with that rule, correspondence with legal counsel does not meet the definition of legal documents. Correspondence to counsel may not be typed in the library and may not be saved to a DOC thumb drive assigned for AIC use. If you have correspondence with your attorney saved to your assigned library thumb drive, please submit a Library Request form for time to come to the library, print, and delete the correspondence.

#### **Updates from Transitions:**

Open resource hours for Transitions are every Friday from 800 am to 1000 am.

Flagging class is scheduled for 1/13/2024, Saturday, from 700 am to 1200pm. There are flyers posted in the units on how to pay for the class. If you have any questions, send a kyte to Transitions.

Re-entry books are available for check out. There is a list of books available on the unit bulletin board. If you are interested either send a kyte for the list/or to reserve to Ms. Enomoto-Haole or come out on Fridays at open resource hours to check it out.

December 11, 2023, at 900am we will have a Prison Scholar Fund representative here at SCI to talk about the affordable connectivity program that will get discounts for a cell phone and free service. If you are interested in attending, please send a kyte Ms. Enomoto so I can place you on a call out.

#### Tattoo removal program:

Vitality Spa has graciously offered tattoo removal services free of charge for up to 4 people per year. If you are interested and believe you meet the criteria listed below, please send a kyte to Ms. Enomoto-Haole. Here are the criteria:

Be committed to the process as the treatment is done in phases and could take up to 6 months to 1 year to complete.

Be willing to take before/after pictures to be used on the website/social media.

Be local within Salem/Keizer/Polk/Dallas or have reliable transportation.

Releasing within 6 months to 1 year.

Focus would be more on removal of gang tattoos or tattoos that may hinder employment opportunities around the face, hands, neck, arms.

Serious about changing your lifestyle.

Possess clear conduct within the past 12 months.

Programming: working, school or utilizing every resource that is available to you.

Some medical conditions that may make you ineligible are:

If you were diagnosed or treated for any type of skin cancer.

If you are out in the sun most of the time such as for work.

If you have a compromised immune system.



#### Counselor Update

Counselor Emra is currently out of the office. Counselor Ramirez will be covering her caseload until further notice. Current institution counselors are J. Wagner, K. Wagner, and Ramirez.

#### **Visiting**

Based on the recent number of visitors and space availability in 142, SCI will be allowing three visitors. Anything more than three visitors will require approval by Ms. Garcia, Correctional Rehabilitation Manager (CRM). The visiting points system is in effect. As noted below, each adult in custody (AIC) who is permitted visiting (privileged or basic) shall be allocated visiting points each calendar month in accordance with their incentive level as outlined in <a href="OAR 291-077-0035">OAR 291-077-0035</a> and the respective appendix B. If you have any questions or concerns, please let me know.

#### Visiting Points System

#### 291-127-0430

- (1) The number of visits approved in any calendar month for AICs in a Department of Corrections facility shall be limited in accordance with the following point value system:
- (2) Each AIC who is permitted visiting (privileged or basic) shall be allocated visiting points each calendar month in accordance with their incentive level as outlined in OAR 291-077.
- (3) Visiting points shall not be deducted for a child under the age of three, as long as the child is held during the visiting session. Visiting points shall not be deducted for visitors age 65 and older.
- (4) On weekdays, one point shall be deducted for each visitor per visiting session.
- (5) On weekends and holidays, two points shall be deducted for each visitor per visiting session, except in those Department of Corrections facilities with weekend visiting only, in which case one point shall be deducted for each visitor per visiting session.
- (6) However, visitation periods when points are not deducted may be permitted at the discretion of the superintendent or designee.

# **DO YOU HAVE DIARRHEA?**

It might be caused by a bacteria called Shigella.



# **Protect Yourself and Your Community**

Shigella spreads **VERY EASILY** from one person to another. If you have diarrhea, **FOLLOW** these simple steps:



wash your hands, especially after going to the bathroom.



WAIT to have sex until your diarrhea is completely gone. Use barriers (like condoms or dental dams) during sex.



**DO NOT** prepare food for others while you are sick.



AVOID swimming until you have fully recovered.

Symptoms can include *diarrhea*, *fever*, and *cramping*. Even after you are feeling better, you can still spread *Shigella* in your stool (poop) for several weeks.

### **HOW PEOPLE GET SICK**

Shigella spreads when a person gets poop from a sick person into their mouth. Even microscopic amounts of poop could make someone sick.



#### Hands

Getting Shigella bacteria on your hands then touching your food or mouth.



#### Food

Eating food that was prepared by someone who is sick (or recently sick) with Shigella.



#### Water

Swallowing water while swimming or drinking water contaminated with poop that has Shigella bacteria.



#### Sex

Contact with germs from poop during sexual contact with someone sick or recently sick with Shigelia.

If you think you might have Shigella, talk to your doctor.
