### MINIMUM PHYSICAL PLANT RECRUITMENT FOR CARPENTER SHOP

SRCM (Minimum) Physical Plant has openings in the Carpenter Shop. In order to apply, all of the following criteria must be met (no exceptions): • Clear conduct for 1 1/2 years (No Major DR or Program Failures), • Must already be housed in Minimum, • Classification 3 or less, • No history of escape, or arson, • 10 years or less remaining on sentence

Job Duties may include: • Reads work orders or receives instructions from Supervisor regarding carpentry, • Legible handwriting, basic math and filing abilities, • Able to lift 50 lbs., • Capable of pushing carts of tools to units, • Good Work Ethic and Attitude, • Basic trouble shooting skills and aptitude of construction techniques, • Have basic skills in Carpentry, • Work well in team environment, • Have basic knowledge of hand tools, • Have basic knowledge of test equipment. • Be able to follow detailed instructions, • Be able to follow operational and safety guidelines, • Be able to operate light equipment IE: man lifts, hydraulic jacks, scissor lifts, etc., Be familiar with products such as concrete and various types of wood products, wallboard types, floor insulation, and ceiling coverings, • Have a basic understanding of a blueprint or construction drawing and be able to follow its use from paper to actual construction. **\*\*If you are interested in this program and meet all of the above requirements, send a completed Physical Plant Work Assignment Application; along with an Inmate Communication expressing your interest to Physical Plant (B344). The applications will be screened by members of the Physical Plant staff. Qualified applicants will need to pass a security screening before being contacted for an interview. Applications must be received by December 15, 2023.**

### A NOTE FROM THE MAILROOM

Holiday mail: - The holiday season is upon us! Ensuring that your holiday mail meets the rules is the best way to receive your mail quickly this holiday season! Please inform your family and friends of these helpful ways to ensure you receive your mail. **\*No cards or mail with glitter, string, ribbon, foam, plastic, gems or any other "fixture" to the cards or envelope. This also includes lipstick, perfume, etc.** These items are not allowed per *OAR 291-131-0035 Prohibited Mail*:

◇ (5) *Items Prohibited from Receipt by Mail:* \* (H) Any substance that is unauthorized, including lipstick, crayon, watercolors, paint, correction fluid, wax, glitter, foam, etc; or \* Mail cannot exceed ¼ inch thick. That includes the envelope with the contents in it. There is not a photo max per envelope, it just cannot exceed ¼ inch in thickness.

\*Please ensure that family/friends are labeling the outside of the envelopes correctly. If we do not have the information in its entirety, it will be returned to sender per - *OAR 291-131-0025 Incoming Mail:* \* *Incoming mail shall have on the front of the envelope free from obstruction, the sender's name and return address, and shall be addressed to the inmate using his/her court name and SID number.*

- (b) *If the inmate recipient cannot be positively identified, the mail will be returned to the sender. A reasonable attempt will be made to identify the inmate recipient.*
- (c) *Mail with no return address shall be refused and returned to the U.S. Postal Service or other authorized mail service provider. No notice will be given to the inmate.*

AIC Communications: When sending KYTES, please remember the following things to help with the process.

\*All KYTES are to be placed in the right side of the mail drop cabinet. \*Only fold your KYTE one time on the dotted line. \*Folding your KYTE multiple times or incorrectly may cause your KYTE to be delayed or returned to you. \*Place your last name, first name, and SID number on the lines on the upper left side. On the lower right side place the Staff name, Staff department and Staff mailbox number. \*Lack of correct information may cause your KYTE to be delayed or returned to you.

**SUBJECT: ACRS ADJUSTMENT**

Beginning January 2024, Institution Counselors' caseloads will be adjusted. The Automated Criminal Risk Score (ACRS) adjustment will take place over a period of time. The first round of adjustments is listed below. Caseload sizes will be evaluated again in June 2024 or later. The adjusted cut-offs will determine how often you see your Institution Counselor for services.

#### **January 2024 High/Medium Caseload ACRS CUT-OFFS**

.20 ACRS and higher for OSP, SRCI, SRCM, TRCI, EOIC  
.30 ACRS and higher for CRCI, OSCI, SFFC, PRCF, SCI, WCCF, DRCM, TRCM

.15 ACRS and higher for CCCF, CCCM

ACRS de .20 y superiores para OSP, SRCI, SRCM, TRCI, EOIC  
ACRS de .30 y superiores para CRCI, OSCI, SFFC, PRCF, SCI, WCCF, DRCM, TRCM

ACRS de .15 y superiores para CCCF, CCCM
