

Subject: Electronic Health Records

We have some news to share with you! The people who help take care of you and your health at the Oregon Department of Corrections (DOC) are going to start using a new computer system to keep track of your health information. This new system is called an electronic health record (EHR) system. It's like a big computer file that stores all your health information in one place.

This change is important because it will help your doctors, nurses, behavioral health, and dentists work together more easily. For example, they will be able to see your health information at the same time, rather than having to take turns with the paper chart. The EHR will also make it easier for DOC to share information with outside providers and upon your release.

Even though the new system won't be ready for more than a year, we want to let you know about it now since you may start to see some changes like people onsite installing equipment and scanning records. You don't need to do anything different to get medical care right now.

We know change can be scary, but we want to make sure you have all the information you need. We will keep you updated about the new system through AIC newsletters, articles, and flyers.

PSC Salutes Black History Month

Of the many units that participated in WWII, one of the most distinguished combat units is one you have likely never heard of – the 761st Tank Battalion. Nicknamed the "Black Panthers," their battalion motto was "Come Out Fighting." It was a motto they proved from their first mission to their last. In the early days of WWII, segregation and racial inequality were the order of the day, and there was concern about allowing African American soldiers into combat. It was General Lesley J. McNair, commander of Army Ground Forces, who successfully argued that "colored" units be employed in combat.

The 761st was constituted on March 15, 1942, at Camp Claiborne, Louisiana, where they initially trained in the M5 Stuart Light tank, learning how to maneuver, mount, dismount and maintain their weapons and vehicles. Their final training was at Fort Hood, Texas where they were upgraded to the M4 Sherman medium Tank before deployment to occupy Europe on October 10 1944, where they were assigned to Patton's Third Army.

They saw combat for the first time in November 1944, fighting through towns like Movenvic and Vic-sur-Seille, often taking the leading edge of the advance. At Morville-les-Vic they endured 183 days of continuous combat operations, something no American unit had ever done before. Of their initial deployment strength of thirty-six officers and 676 enlisted men, the 761st suffered 156 casualties in November '44, with 24 killed, 81 wounded and 44 non-combat losses.

In December they would be rushed to aid in the Battle of the Bulge where they aided the 101st Airborne and where they would play a major role in the capture of Tillet, where, while supporting the 87th Infantry Division with just eleven tanks, they took control of the city from the 113th Panzer Brigade after two days of intensive combat, losing 9 tanks in the process.

It was this type of fighting spirit that led to their reputation at wars end as one of the most effective tank battalion of WWII, with the unit receiving the Presidential Unit Citation, and numerous individual awards from the Silver Star down, including over 300 Purple Hearts.

Randy Pope - TRCI Yoga Facilitator & OCE Clerk

Yoga Behind Bars, a Washington based non-profit, aims to introduce yoga into prisons. In 2018, TRCI welcomed an instructor from the group that led a weekly yoga class, first in the visiting room, and then in the chapel. AIC Randy Pope was an early participant in TRCI's yoga class and attended regularly until COVID in 2020. At that point, Randy decided to incorporate yoga into his daily cell routine and continue his practice. With the increased cell time, Randy wanted to keep his aging body more flexible by moving without stress on the body. "Yoga was easy in the cell." 18 months after the yoga class stopped due to COVID restrictions, it resumed with the same instructor. Randy was ecstatic to restart his favorite class at TRCI. After only a few months, the class was unfortunately stopped again, due to the instructor's availability. Randy was devastated, but it didn't deter him from pursuing his practice. Randy dove head first into yoga, and fully invested into learning the art, purchasing his own books and materials. "I didn't want to see another program die!" After tiresome persuasion from friends, Randy spoke with Mr. Cambell at recreation and decided to start a Peer2Peer yoga class when the TRAC opened. Randy passionately loves yoga because it "not only stimulates your mind, but balances health, and makes you feel good at the same time." This is a basic level yoga class and open to 10 AIC's on Monday mornings with hopes to expand in the future. If you're interested in a low impact workout that addresses your emotional, mental, spiritual, and physical health, then join Randy and the crew. It's a unique and tranquil setting to start your week by leaving prison behind for 1 hour.

Pursuant to ORS 183.390(2), the Oregon Department of Corrections invites comment on OAR 291-105-0015 including any comments on whether options exist for achieving the rule's substantive goals in a way that reduces any negative economic impact on businesses. Common Grounds is now offering coffee to all visitors and AIC's in the visiting room!

Please follow the below process to order:

For Visitors: Visitors may purchase \$4 individual coffee tickets upon checking in at the visiting entrance. Visitors may also purchase 1 coffee ticket per AIC.

• 1 ticket per visitor



• 1 ticket per AIC

Upon entering the visiting room, visitors must communicate to the visiting room staff that they purchased coffee tickets. They will then receive a coffee order form to fill out and return to the visiting staff.

- All orders are picked up by Common Grounds barista's at 8:30am & 1:30pm
- Coffee orders will be fulfilled and delivered shortly after

For AIC's: AIC's may bring a maximum of 1 coffee ticket from their housing unit to purchase a drink as well.

Savings Options for Adults in Custody

What is the Transitional Savings Account (TRSA)?

- Funds in the TRSA are protected from debt/obligation collection and garnishment.
- Established per SB844/ORS 423.105 as a means for AIC's to save funds for release from ODOC custody.
- 5% of each eligible deposit is applied into an AIC's TRSA until the account reaches \$500.
- AIC's may elect to transfer funds into their TRSA by submitting a Trust Account Transfer Request form (CD1832) up to \$500.
- AIC's may continue a 5% deduction of their eligible deposits beyond \$500 if court-ordered financial obligations (COFOs) are satisfied.
- Funds in the TRSA are not available to AIC's until reentry into the community (*no exceptions*).

What is the General Savings Account (GS)?

- Funds in the GS Trust Account are not protected from debt/obligation collection or garnishment.
- Established as an optional means for AIC's to save funds outside of the TRSA.
- AIC's may elect to transfer funds into the GS Trust Account once per calendar month by submitting a Trust Account Transfer Request Form (CD1832).
- Funds in this account are not available until the AIC releases from ODOC custody; an exception may be granted by the CFO or designee per OAR 291 Div. 158.

What About External Savings Accounts?

AIC's may have accounts with external banking institutions however, ODOC staff are not able to facilitate. AIC's may not have unauthorized money items in their possession (such as checks).

Note: Trust Account Transfer Request Forms (CD1832) are available on AIC housing units or through Business Services. If the amount being transferred is excessive, it will be limited. The minimum transfer amount is \$5.00.
