SET YOUR BUTTERFLIES FREE!

Maybe you've seen the signs on the G/H yard asking that you not disturb the garden there and wondered: "What garden? There's nothing there but a bunch of weeds! And who are those people out there digging in the dirt, and why are they so protective of those weeds?"

But as Ralph Waldo Emerson said, "A weed is just a plant whose virtues we have not yet discovered."

In this case, that "weed" is called plantago, and the people tending it are the Plantago Team, one-half of the Taylor's Checkerspot Butterfly (TCB) Recovery Project. The other half of the team is the Butterfly Lab team. You may have seen them in the H Unit meeting room facing the yard, hard at work with their microscopes and forceps raising the larvae that will become butterflies. Together, working as one, they are striving to help save this cute little guy from extinction. The life-span of the Taylor's Checkerspot Butterfly is only about 1 year. It only lives as a butterfly for about 2 weeks.

And just like us, the Checkerspot Butterfly has its favorite food, which is-you guessed it-plantago! The plantago is also its nursery, where it lays its eggs for the next generation.

Why are we making such a fuss over one species of butterfly? Well, the Taylor's Checkerspot's habitat has shrunk over the years from 70 locations throughout the Pacific Northwest and Canada, to a mere 13, and only 2 of them in Oregon (both in the same county.) It was put on the Endangered Species Act list in 2001 when it was discovered that their habitat had shrunk so drastically. In 2005, the State of Washington declared that the Taylor's Checkerspot Butterfly is "the rarest endemic butterfly in one of the rarest ecosystems in North America."

There are a variety of reasons why we should be making the effort to save them from extinction, but for me the best one is that we humans are responsible for their decline and loss of habitat, through development, urban growth and recreation, through overuse of pesticides and herbicides, and through our contribution to climate change.

Shouldn't we then show some responsibility for trying to save them?

Those of us fortunate enough to work on this project love the butterflies and love helping them to survive and flourish. As one Plantago Team member said, "I have learned and taken so much from plantago in the last few years. I look forward to this year with them. I appreciate being able to participate in this so much, and all the helpful crew I work with. It's truly amazing! Thank you!"

We wish you could all be part of this experience. Sadly, that's not possible, but you <u>can</u> help by not walking in the garden or picking any of the plants there. Everything we've planted has a purpose in helping to ensure a steady supply of nutritious food for growing young caterpillars. You can also help by not disturbing their hibernation boxes located next to the phones on G/H yard.

By helping us this way, know that you are actually doing your part to save this beautiful butterfly.

In recent weeks, LOCC members have been hearing questions around the facility:

Glad you asked! Because we pride ourselves on transparency, integrity, and open, honest communication, we're happy to share our vision with you. It can be summed up in our club's mission statement:

"The mission of LOCC is to support the lifer's community while advocating for quality of life improvements for all Coffee Creek residents and rebuilding public trust and credibility."

LOCC'S NUMBER ONE
PRIORITY IS TO SUPPORT ITS
CLUB MEMBERS.

LOCC's number one priority is to support its club members.

Who can join LOCC? Any AIC who was sentenced to 15 years or more. We support our valued members mainly through political activism, advocating for improved conditions and through

member education.

Each month, we have a business meeting, affectionately known as political "fight club."

...but we can talk about this fight club.

We have hosted guest speakers, such as our Ombudsman, our Gender Response Analyst, speakers on Sustainability and Grant Writing, a State Representative, two attorneys with OJRC, an Administration Representative for Transitional Services and two experts in human trafficking.

We have also hosted a workshop with the Grievance Coordinator on how to write effective DOC Grievances. Since our members attended this workshop, *almost* ALL of our grievances have been accepted!

We also host a monthly club game night and a monthly movie night with snacks.

With our fundraising events, we are self-supporting. **There are no membership dues!** As a sanctioned club, we may have four fundraisers per fiscal year, approved at-cost events and an annual banquet for our members and their guests.

LOCC's second priority is finding ways to make life better for *all* of the residents here at Coffee Creek. We do this in ways most never see, behind the scenes, interacting with staff and

- Reclaiming space for AIC use
- Building an outdoor amphitheater for summer events
- A parole board preparation program
- Working with Transition Services to provide releasing women with an outreach program to prevent trafficking
- Improvements to house TV channels
- Decibel reduction advocacy
- Americans with Disabilities advocacy
- Environmental enrichment

We believe that if we attend to the first two priorities correctly, the third priority, to restore public trust and credibility, will take care of itself.

OUR THIRD PRIORITY: TO RESTORE PUBLIC TRUST AND CREDIBILITY.

LOCC is resulting in knowledgeable and empowered leaders in our community, equipped to carry out our mission.

We are still a very young club. Our Constitution was signed, making us a sanctioned club, just over a year ago.

For comparison, Lifers Unlimited Club at OSP has been in operation since 1969!

LOCC is the first AIC lead, sanctioned club *ever* in the history of the female corrections division in Oregon. The fight for equality and parity with other DOC facilities has taken years, and the victory was not easily won.

We are proud of this accomplishment. Our club is tenacious, persistent, and dedicated to achieving our goals. **We will not**



quit. Ever.

OUR FIRST ART CLASS



You **CAN** order:

Black pens

Spring(click) pens

Glue sticks

Paints (must be water soluble)

From Health Services:

The Pharmacy & Therapeutics Committee recently met to review the use of boric acid as a medical agent in the treatment of vaginosis. It was decided that other medications such as metronidazole or clindamycin are more effective, and that using boric acid for vaginosis is an outdated practice. The committee decided to stop prescribing boric acid. Metronidazole and clindamycin are already available and should be used in place of boric acid to treat vaginosis. Although there is no harm in continuing to use your existing medication of boric acid, no new prescription orders will be given. Refills of current prescriptions will be allowed until April 1, 2024. If you have questions about this change, you are welcome to speak with your medical provider.

What is blood pressure?

Blood pressure is the pressure of blood pushing against the walls of your arteries. Arteries carry blood from your heart to other parts of your body. Your blood pressure normally rises and falls throughout the day. Blood pressure is measured using two numbers: The first number, called *systolic* blood pressure, measures the pressure in your arteries when your heart beats. The second number, called *diastolic* blood pressure, measures the pressure in your arteries when your heart rests between beats.

What is high blood pressure (hypertension)?

High blood pressure, also called hypertension, is blood pressure that is higher than normal. Having a blood pressure that measures consistently above normal may result in a diagnosis of high blood pressure (or hypertension). The higher your blood pressure levels, the more risk you have for other health problems, such as heart disease, heart attack, and stroke. If you are diagnosed with high blood pressure, talk with health services about your blood pressure levels.

High blood pressure usually has **NO** warning signs or symptoms, and many people do not know they have it. Measuring your blood pressure is the only way to know whether you have high blood pressure.

What causes high blood pressure?

High blood pressure usually develops over time. It can happen because of unhealthy lifestyle choices, such as not getting enough regular physical activity. Certain health conditions, such as diabetes and being overweight, can also increase the risk for developing high blood pressure. High blood pressure can also happen during pregnancy.

What problems does high blood pressure cause?

High blood pressure can damage your health in many ways. It can seriously hurt important organs like your heart, brain, kidneys, and eyes. The good news is that, in most cases, you can manage your blood pressure to lower your risk for serious health problems. These health problems include heart attack, heart disease, stroke, and kidney disease.

How do I know if I have high blood pressure?

Talk with health services about regularly measuring your blood pressure with each clinic visit. High blood pressure is called the "silent killer" because it usually has no warning signs or symptoms, and many people do not know they have it.

What can I do to prevent or manage high blood pressure?

Many people with high blood pressure can lower their blood pressure consistently to a healthy range by making **lifestyle changes**: Getting at least 150 minutes of physical activity each week (about 30 minutes a day, 5 days a week), not smoking, eating a healthy diet, including limiting sodium (salt) and alcohol, keeping a healthy weight, and managing stress. In addition to making positive lifestyle changes, you may need to **take medicine** to manage your blood pressure. Talk with health services if you think you have high blood pressure or if you've been told you have high blood pressure but do not have it under control.



COVID-19 Vaccine and Booster Dose Update – March 2024

The COVID-19 virus is still present in our institutions and communities, and vaccines continue to be the safest and most effective way to protect from COVID-19 infection. The Centers for Disease Control and Prevention (CDC) has authorized another vaccine booster series for COVID-19. Health Services will be approaching all individuals to inquire if vaccination is desired. If you do not wish to be vaccinated, or receive boosters, you can opt-out.

COVID-19 Booster Vaccines will be offered to those patients that are 65 years of age and older, as well as to patients who may be immunocompromised. These patients should receive two doses of Spikevax (Moderna) 23-24 vaccine to be up to date in vaccines. If you are under 65 years of age, are not immunocompromised, and have already received your COVID-19 Spikevax (Moderna) 23-24 vaccine – you are up to date on your vaccines and do not need another. If you have not received your COVID-19 Spikevax (Moderna) 23-24 vaccine, and you want it, please send a kyte to medical to receive it. If you have questions, contact your health care provider.



QPR Suicide Prevention Classes Are Now Available @CCCM

QPR is an emergency mental health intervention for suicidal persons created in 1995 by Paul Quinnet. AIC's will be trained how to recognize the warning signs of a person who may be experiencing mental or emotional stressors and how to Question, Persuade, and Refer them to help.

This class will be held in D5 on Saturday from 2:30 – 3:30 pm.

Class size is limited to 12 AIC's at a time. All Incentive levels are welcome to participate in this class *except* AIC's on LOP status. Please send a kyte* if you are interested in attending a QPR Class to:

Financial Services Informational Briefing

Adult in Custody (AIC) 2024 Tax Information

The Department of Corrections (DOC) will not provide federal or state tax forms to AICs.

- AICs may write or call the Internal Revenue Service (IRS) or Oregon Department of Revenue to request tax forms.
- AICs may elect to reach out to their friends and family to request they send tax forms in through the mail. All incoming mail is subject to the Departments rule on mail, 291-131-0025.
- DOC staff / legal assistants are not authorized to provide tax advice or status updates on filings to AICs.
- AICs may appoint a qualified and trusted person as their power of attorney (POA) to assist with the tax filing process. POA forms can be obtained by submitting a Library Request form (CD1714).

State and Federal taxes due date: April 15th, 2024

AICs will need to use their own preaddressed postage paid envelope for tax correspondence and filings.

AIC Newsletter Article - 2022

Prison Rape Elimination Act (PREA Information)

The Oregon Department of Corrections (ODOC) has a zero tolerance policy for sexual abuse, sexual harassment and for retaliation for reporting an incident. You may report in person to any staff, through an AIC communication, through the grievance system, by calling the PREA hotline by making a language selection, then dialing 91 from any AIC phone.

Filing an Anonymous PREA Report

If you are uneasy about filing a PREA allegation, you may file an anonymous report with an outside agency.

Please indicate in the beginning of your letter you are filing a PREA allegation and you are requesting to remain anonymous.

The Governor's Office will refer all anonymous allegations to the DOC PREA Coordinator to assure an investigation is completed based off the information that is provided.

Opposite Gender Viewing/Announcements

Opposite gender staff announcement themselves when entering a housing unit by ringing a bell. This must be done any time the status quo of the gender supervision on a housing unit changes (if there is already an opposite gender staff on the unit then there is not needed to re-announce). When you hear the doorbell, opposite gender staff will be entering the housing unit so please make sure you are covered up appropriately.

It is also important you undress in the appropriate locations. If you are located in a bunk area, there are cameras throughout the facility so the designated changing/bathroom areas are the only areas you should be without undergarments. Opposite gender viewing may happen incidentally when staff are conducting routine cell checks. You can minimize this by keeping aware of the gender of supervision in your housing unit and ensuring you cover up when possible.

Community-Based PREA Advocacy (Support) Program

ODOC has partnered with community based, confidential advocates of sexual abuse victims to provide services to AICs.

AICs at ODOC who have experienced sexual abuse may reach a community-based advocate by making a language selection, entering your AIC PIN, then press 0*711 AIC telephone systems, or may request a private call through the PREA Compliance Manager at the facility. Advocates provide victims of sexual abuse information about their options, resources, information and emotional support. There is no charge for calls to advocates.

The community-based advocacy crisis line is for individuals needing assistance coping with sexual abuse related issues and should not be used for other purposes.

Telephone calls and mail with community-based advocacy centers is considered privileged communication and will be handled similar to legal calls/official mail. All advocacy calls are not monitored or recorded.

Advocates provide confidential support and crisis intervention, inform you about the investigation and medical examination process, educate you about healing from sexual abuse and offer resources and referrals

Advocates will not tell you what to do, communicate with the institution unless you request them to do so and sign a release and will not provide legal advice.

Community-based advocacy centers provide sexual abuse support to people of all genders. Community-based advocates will not report unless you request them to do so and if you sign a release of information.

Artículo Boletín AIC – 2022

Ley de Eliminación de Violaciones en Prisión (Información PREA)

El Departamento Correccional de Oregon (ODOC) tiene cero tolerancias para el abuso sexual, el acoso sexual, y las represalias por denunciar un incidente. Puede informar en persona a cualquier miembro personal a través de una comunicación de AIC (adulto bajo custodia) o a través del sistema de quejas. Puede llamar a la línea directa de PREA, seleccionar el idioma y luego marcar 91 de cualquier teléfono de AIC.

Presentación de un informe PREA anónimo

Si no está seguro de presentar una acusación ante PREA, puede presentar un informe anónimo con una agencia externa.

Por favor indique al comienzo de su carta, que está presentando una denuncia ante PREA y quiere permanecer anónimo. La Oficina del Gobernador remitirá todas las denuncias anónimas al Coordinador de PREA para garantizar que se complete una investigación basada en la información proporcionada.

Visualización/Anuncios de género opuesto

El personal del género opuesto se anunciará cuando ingresa a una unidad de vivienda, tocando un timbre. Esto debe hacerse cada vez que cambie el statu quo de la supervisión de género en una unidad de vivienda (si ya hay un miembro del personal del sexo opuesto en la unidad, entonces no es necesario volver a anunciar). Cuando escuche el timbre, el personal del sexo opuesto estará ingresando a la unidad de vivienda, así que asegúrese de estar cubierto adecuadamente.

También es importante que se desnude en los lugares apropiados. Si se encuentra en un área de literas, hay cámaras en toda la instalación. Existen áreas designadas para cambiarse, el baño es la única área en la que puede estar sin ropa interior. La visualización de sexo opuesto puede ocurrir incidentalmente cuando el personal realiza controles de celda de rutina. Puede minimizar esto siendo consciente del género de la supervisión en su unidad de vivienda y asegurándose de cubrirse cuando sea posible.

Programa de defensa (apoyo) basado en la comunidad PREA

ODOC se ha asociado con defensores confidenciales basados en la comunidad de víctimas de abuso sexual para brindar servicios a los AIC.

Los AIC en ODOC que han pasado por abuso sexual pueden comunicarse con un defensor comunitario seleccionando un idioma, ingresando su PIN de AIC, luego presionando 0*711 sistemas telefónicos. También pueden solicitar una llamada privada a través del Gerente de Cumplimiento de PREA en la instalación. Los defensores brindan a las víctimas de abuso sexual información sobre sus opciones, recursos, y apoyo emocional. No hay ningún cargo por las llamadas a los defensores.

La línea de crisis de defensa basada en la comunidad es para personas que necesitan ayuda acerca de los problemas relacionados con el abuso sexual y no debe usarse para otros fines.

Las llamadas telefónicas y el correo con los centros de defensa basados en la comunidad se consideran comunicaciones privilegiadas y se manejarán de manera similar a las llamadas legales/correo oficial. Todas las llamadas de defensa no son monitoreadas ni grabadas.

Los defensores brindan apoyo confidencial e intervención en crisis, le informaran sobre la investigación y el proceso del examen médico, lo educaran sobre cómo curarse del abuso sexual y ofrecen recursos y referencias.

Los defensores <u>no</u> le dirán qué hacer, no se comunicarán con la institución a menos de que usted les solicite que lo hagan y firmen un comunicado. No le brindarán asesoramiento legal.

Los centros de defensa basados en la comunidad brindaran apoyo en caso de abuso sexual a personas de todos los géneros. Los defensores comunitarios no informarán a nadie a menos de que usted les solicite que lo hagan y si usted firma una divulgación de información.

Approx 20 ins [51 cm] long excluding handles.

MATERIALS

Bernat_® Handicrafter Cotton

(50 g/1.75 oz; 73 m/80 yds) 13712 (Hot Green) **4 balls**

Size 5 mm (U.S. H or 8) crochet hook **or size needed to obtain gauge.**

GAUGE

13 sc and 14 rows = 4 ins [10 cm].

INSTRUCTIONS

Body: Ch 39.

1st row: (RS). 1 sc in 2nd ch from hook. 1 sc in each ch to end of ch. 38 sc. Turn.

2nd to 4th rows: Ch 1. 1 sc in each sc to end of row. Turn. Proceed in pat as follows:

1st row: Ch 7 (counts as tr and ch 3). (Yoh) twice. Draw up a loop in next st. (Yoh and draw through 2 loops on hook) twice. Yoh and draw through all loops on hook. *Ch 5. [(Yoh) twice. Draw up a loop in next st. (Yoh and draw through 2 loops on hook) twice] twice. Yoh and draw through all 3 loops on hook – tr2tog made. Rep from * to last sc. Ch 3. 1 tr in last sc. Turn.

2nd row: Ch 5 (counts as tr and ch 1). Miss next 3 ch. Tr in next st. *Ch 5. (Yoh) twice. Draw up a loop in same st as before. (Yoh and draw through 2 loops on hook) twice. Miss next 5-ch sp. (Yoh) twice. Draw up a loop in next st. (Yoh

and draw through 2 loops on hook) twice. Yoh and draw through all 3 loops on hook – tr2tog over 2 sts made. Rep from * to last tr. Tr2tog over last st worked and next tr. Turn.

3rd row: Ch 7 (counts as tr and ch 3). Tr2tog over first st and next tr2tog. *Ch 5. Tr2tog over st just worked and next tr2tog. Rep from * to last tr. Ch 3. 1 tr in 4th ch of ch 5. Turn.

Rep 2nd and 3rd rows until work from beg measures approx 20 ins [51 cm], ending with 3rd row.

Next row: Ch 1. 1 sc in first st. *2 sc in next ch-5 sp. Rep from * to turning ch 7. 1 sc in ch-7 sp. 1 sc in 4th ch of ch 7. Turn.

Next 3 rows: Ch 1. 1 sc in each sc to end of row. Turn. Fasten off at end of last row.

Handles: With RS of work facing join yarn with sl st to top left corner of Bag. Ch 1. Work 30 sc evenly across side of Bag. Turn.

Next row: Ch 57 (handle). 1 sc in 2nd ch from hook. 1 sc in each of next 55 ch. 1 sc in each sc to end of row. Turn. 86 sc in total.

Next 2 rows: Ch 1. 1 sc in each sc to end of row. Turn.

Fasten off at end of last row, leaving a long end. Sew end of handle in position.

Rep for other side.
